Message from the Board President:

"For I know the plans I have for you, declares the Lord, plans for welfare and not for evil, to give you a future and a hope." Jeremiah 29:11

It is frustrating sometimes when our expectations do not align with our reality. When I accepted the charge to serve as Vice President of the Board of Trustees of DCC in 2018, I had expectations of what it would look like when I assumed the Presidency of the Board on July 1, 2020. I can assure you that my expectations had absolutely nothing in common with the reality in which we are all currently living. Alas, we live in a world of reality, not expectations.

The last few months have been very hard, even for the most optimistic Christian. Humans are social creatures – we are not meant to live in isolation. I believe the sacrifices we have been making as a society are necessary, and the data appears to show this is correct. Where New York was once the epicenter of the COVID-19 pandemic, we are currently one of only four states on track to contain the virus. No matter how much we want to get back to normal, the news is currently rife with stories of the risks involved with not taking appropriate precautions as we look to reopen our society.

The Board of Trustees has formed a committee to provide guidance on when and how DCC will reopen all facets of its operations. The Board voted last week to allow DCC employees to return to return to work at the church, to allow our rental groups to return to the church building, and to allow small group gatherings to return, using the social distance and safety guidelines set forth by the state.

What of worship services? The New York state government has provided vague and conflicting information as to what will and will not be allowed in Phase IV of reopening. Due to the rapidly evolving nature of this situation, the "reopening committee" has recommended we wait to see what will and will not be allowed regarding in-person worship (capacity, music, etc.) before formulating a plan for reopening. Once we have more guidance, DCC will send out a survey to the congregation to help church leadership determine our path to reopening.

Four months ago almost none of us knew what a "Zoom meeting" was. Now remote communication has become a way of life. I believe we are blessed with the high-quality virtual experience our worship team has provided us these last three months. I am thankful for this, but I look forward to again seeing you on Sundays. Stay safe.

Reopening Task Force Update

The safety of DeWitt Community Church is of the utmost importance and as a church, we are called by Christ to care for another. The Reopening Task Force gathered to give wise counsel to the Trustees. We have reviewed as much scientific, medical, and social data as possible. We must promote community engagement in a safe environment. We are a multigenerational congregation, and because our church body includes people with various kinds of heightened risk factors, we need to advise for the good of the whole, not for the wishes of any subset of the congregation. We believe it will be important when we come back to come back together as much as possible.

According to experts, 90% of coronavirus deaths come from people 50 and older. Churches are in one of the highest risk zones for Coronavirus inflection. Choir and congregational singing is shown to be one of the most infectious ways to potentially spread the Coronavirus, according to the Center for Disease Control. We take these statistics seriously about the high-risk in-person worship presents for our church.

Opening a church is challenging as we are different from businesses as we have a variety of group functions and large-scale gatherings, where the known risk of accidentally spreading infection is exponentially higher. We are relational in our ministry, not transactional, and this makes a fundamental difference in how and when we can reopen. With these realities guiding our thoughts, the task force is now working on a matrix of decision making that considers aspects of the church's ministry and how we might adapt in several possible environments that will emerge. We are envisioning a time when very small groups might be allowed, then medium-size groups being allowed, then larger groups allowed. We are evaluating each of these environments for things like worship, Sunday School, offices, committee and team meetings, food service, and volunteer mission gatherings.

Since the State of New York allows has allowed in-person worship to resume, but has not updated the capacity limited beyond 33%, DCC will not reopen automatically for in-person worship in phase 4 of the New York State plan. We purpose a phasing and evaluation mindset to make decisions. Therefore, we recommended the following to the Board of Trustees, which was approved: Continue virtual worship and online engagement through July 31, 2020, and reevaluate if in-person worship can resume. Since an in-person worship service would consist of no congregation singing, social distance, reduced capacity, a potential conflict of reserving limited space for worship, no hymnals, no bulletins, and no child care, virtual service would produce a safe and quality worship experience. Right now, an in-person worship service would be a limited quality worship experience, Based on data and other recommendations, we could resume in August or September, but we will take a month to month approach to evaluation.

Continue to suspend in-church weddings, baptisms, and funerals through July 31, 2020. All the weddings or baptisms have been rescheduled or canceled. Graveside and funeral home services would be conducted by clergy, in addition to graveside services.

The church building would be open for limited use of rental groups and small social distance gatherings. Rental groups and smaller groups must follow social distance guidelines. Food and drink will not be served by the church.

In addition, the follow actions will be taken:

We encourage church groups and committees to continue to use Zoom and creative social distance outdoor gatherings. We encourage church groups to create outdoor meetups and safe activities.

Send out a survey via email to collection information regarding what the congregation is comfortable with if in-person church worship resumes. The survey would supply data for decision making.

Church staff can operate on a blended model of at home work and in office, in accordance with State requirements.

CORONAVIRUS DISEASE 2019 (COVID-19) UPDATE

The work of the American Red Cross never stops, thank you for continuing to stand with us during this coronavirus crisis. Your upcoming blood drive is very important to ensure we can continue to meet all blood needs. There's currently an urgent need for blood donors of all blood types to give now. Our commitment to operate blood drives in the safest way possible for our donors, volunteers and staff remains a top priority.

SAFETY FIRST

At each blood drive, Red Cross staff already follow the highest standards of safety and infection control. In addition to our standard procedures, we have implemented additional precautions that you'll notice at your local blood drive:

- Checking temperatures of staff and donors before entering a drive to make sure they are healthy.
- Providing hand sanitizer for use before the drive, as well as throughout the donation process.
- Following social distancing between donors including entry, donation and refreshment areas.
- Ensuring face masks or coverings are worn by both staff and donors.
- · Routinely disinfecting surfaces, equipment and donor-touched areas.
- Wearing gloves, and changing gloves often.
- Using sterile collection sets and an aseptic scrub for every donation.
